CONDITIONS AND TERMS OF HAUL OUT/YARD STORAGE

- 1. Subject to space availability the Club undertakes to handle Members craft endeavouring to meet owners requirements as far as possible.
- 2. Applications for Haul Out & Storage will be dealt with on first come first served basis.
- 3. With the exception of Wooden Hulled Craft (12 weeks) the length of time in the yard is for a maximum of 6 weeks October February (incl.) or 4 weeks March and April. Long Term Storage (min. 22 weeks, max. 24 weeks) will be allocated subject to availability.
- 4. Those craft exceeding their allocated time will be penalized as per General Committee Policy.
- 5. All craft must have suitable support cradles or must be supported by stable rigid blocking approved by the Yard and Haven Committee. Cradles should be in the Yard, clearly named and ready to accept craft and reported to the Bosun not more than one week before notified Haul Out date. **ALL cradles and means of support must be removed from the Yard immediately the boat is launched.**
- 6. Members must endeavour to keep Car Park and area around their craft clean and ensure that no damage is done to the Car Park surface. All rubbish must be removed from the yard.
- 7. All work to be undertaken on craft by outside contractors must be cleared with the office BEFORE work commences. All outside contractors must report to the office before starting work on craft on Club premises and show Proof of Indemnity Insurance.
- 8 Members must provide on their craft and maintain in efficient working order at least one suitable Fire Extinguisher.
- 9. Craft and gear are repaired, worked on, moved, stored and otherwise managed and kept at the sole risk of the owner, and the Club and its employees accept no responsibility for loss, damage or delay occurring from any cause whatsoever.

 The owner must therefore ensure that his craft and/or property is adequately insured against all risks
 - The owner must therefore ensure that his craft and/or property is adequately insured against all risks and effect insurance against Third Party risks for a minimum of £3,000,000 as he may be liable for damage caused by his craft, himself or his crew whilst on or about the Clubs premises. The member is responsible for all health and safety issues concerning their boat whilst on the hard and the Club accepts no liability after the craft has been blocked off by the yard staff. All persons using any part of the Club premises and/or facilities for whatever purpose and whether by invitation or otherwise do so at their own risk, the exception to this clause being to the extent that such loss, theft or damage may be caused by the negligence or wilful acts of the Club, or those for whom the Club are responsible.
- 10. The method of hauling any craft shall be at the sole discretion of the General Committee.
- 11. All craft (Winter Period) must be launched by April 30th and the Committee reserve the right to withdraw Haul Out/Re-Launch facilities from members who in their opinion do not endeavour to meet the Haul Out/Launch conditions.
- 12. Haul Out/H.P.C./Re-Launch programme operates Monday to Friday inclusive, <u>excluding</u> Bank Holidays.
- 13. The Club reserves the right to measure all boats to confirm compliance with Haven Byelaw 9. Any vessels found to be in excess of the allowable overall lengths will be referred to General Committee.

CHARGES FOR STORAGE (OCT. 1ST 2021 - SEPT. 30TH 2022)

Oct. 1st until April 30th – Short Term Storage

All craft in the yard during this period will be allowed a <u>maximum of 6 weeks ashore (Oct.- Feb. incl.)</u> and a maximum of 4 Weeks ashore (March and April) for GRP craft and a maximum of 12 weeks for <u>wooden craft</u>. **Penalties will be imposed on those who exceed the allowed time.**

a. Yard space is charged by the sq mt per week (or part thereof) at £0.85 per sq. mt

b. Craft ashore for specialist bottom/hull treatments *requiring longer than* the 6, 4 or 12 week periods will be allocated space between main gates and the boat shed, subject to availability, and charged at

£1.70 per sq. mt

* Berth/Mooring holders have a 2 week *storage* period included in their Haven Berth/Mooring fees if hauled out and re-launched between 1st October – 18th December 2021. All other charges will apply as normal.

Should any storage ashore booking over-run, a 20% premium will be applied across the entire period of time ashore.

Oct. 1st – April 30th - Long Term Storage (max.30 Craft)

Members who wish to take up storage for the winter must have

a minimum of 22 weeks to be **paid in advance** at £1.70 per sq. mt

May 1^{st} – Sept 30^{th} Max. 2 weeks £0.90 per sq. mt

Max. 10 boats in the yard at any one time during this period.

Priority for space to Berth holders, Mooring holders, then space allocated on length of membership.

other than incorporated in above will be charged at
Use of Hoist/Forklift and Driver for lifts other than those above
Use of Launch and Staff (tow etc.)

The launch service to Club moorings in the Summer months is included in mooring fees.

N.B. Members are reminded that the Haul out/H.P.C./Re-launch service is suspended throughout the Christmas and New Year period.
